Meeting called to order at 1911 by Nancy M.

- -Kevin O. asked for nominations for the Treasurer position. Londa J. nominated Nancy M. for the position of Treasurer. Nancy M. accepted the offer. Alice L. made a motion to move Nancy M. into the position of Treasurer of the Ballinger Neighborhood Association, replacing the current Treasurer, Kathy P. Kevin O. seconded the motion and it was voted in unanimously.
