**GARDENER RESPONSIBILITIES** 

# 1. Please maintain your plot all year

- a) Activate your plot by April 1.
- b) Winterize your plot with a cover crop, organic mulch or winter crops by November 15.
- c) Notify Helen the garden coordinator if you are unable to maintain the plot so that it can be reassigned.

# 2. Keep public spaces clear and safe

- a) Plot holders are responsible for keeping the pathways around their plots free of weeds and debris.
- b) Keep vining crops confined to your plot. Do not allow them to obstruct pathways or neighbor's plots.
- c) Invasive plants and weeds are not allowed plots.
- d) Follow the compost and weed disposal practices.
- e) Water responsibly, using water from the barrels only, and treat hoses carefully.
- f) Maintain shared equipment and return tools and supplies to the garden shed.
- g) Plot holders are expected to participate in at least one organized garden work party each year.

### 3. Garden organically

Ballinger Neighborhood Community Garden is an organic garden; gardeners must adhere to organic growing practices. Use of synthetic chemical fertilizers, herbicides or pesticides is not permitted. <a href="http://www.organicgardeninfo.com">http://www.organicgardeninfo.com</a>

### 4. Be a good neighbor

- a) Do not allow tall plants to shade your neighbor. Trees, tall fences, permanent structures and tires are not allowed in plots.
- b) Respect your adjacent plot holder's space, do not water their plot or enter their plot.
- c) Registered service dogs only please, use bags and pack out waste, do not use garden tools for this purpose. The school does not allow animals on the property and does not provide refuse containers.
- d) Supervised children are welcome and highly encouraged to participate in the gardening process.
- e) Resolve differences respectfully.
